AN ORDINANCE AMENDING TITLE 1, CHAPTERS 7 AND 10 OF THE ORLAND PARK VILLAGE CODE (VILLAGE MANAGER'S AUTHORITY REGARDING BIDS AND PROPOSALS FOR WORK AND PUBLIC IMPROVEMENTS)

BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

SECTION 1

The following is hereby added as Subsection 4-7vi to Title 1, Chapter 7, Section 1:

"vi. In connection with any work or public improvement bid or proposal, the Village Manager, or his/her designee, shall fix the amount of any performance bond or any labor and material payment bond and in circumstances deemed appropriate by the Village Manager he/she may waive the requirement of a performance bond and/or labor and material payment bond."

SECTION 2

Title 1, Chapter 10, Section 3, Subsection 2, Paragraph 3, is hereby repealed and replaced with the following:

"Such notice shall also contain such conditions and restrictions as to bids, prerequisites as to bidders, obtaining of plans and specifications, security, deposits, withdrawal or rejection of bids, proposals, contracts and performance bonds as the Village Manager, or his/her designee, may direct."

SECTION 3

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of their conflict herewith.

SECTION 4

This Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner prescribed by law.
