AN ORDINANCE AMENDING TITLE 7 CHAPTER 4 OF THE ORLAND PARK MUNICIPAL CODE, REGARDING CLASS I LIQUOR LICENSES IN THE VILLAGE OF ORLAND PARK, COOK AND WILL COUNTIES, ILLINOIS

Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

SECTION 1

Section 7-4-6 (9) of the Orland Park Municipal Code is hereby amended to decrease the number of Class I licenses issued to make sales at retail of alcoholic liquor from the comedy club premises specified, for use or consumption only on the premises where sold, from one (1) to zero (0). The last sentence of 7-4-6(9) shall be deleted and the following substituted: "No licenses of this class shall be issued."

SECTION 2

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed insofar as they conflict herewith.

SECTION 3

This Ordinance shall be effective immediately upon its passage and approval in the manner provided by law.
