ORDINANCE AUTHORIZING THE DONATION OF MUNICIPAL PROPERTY (GYM AND EXERCISE EQUIPMENT)

WHEREAS, the Village of Orland Park, Cook and Will Counties, Illinois (the “Village”) is an Illinois home rule municipality; and

WHEREAS, the Village Police Department, over a year ago, moved to new and expanded headquarters, with a fully equipped work out/gym room, and therefore the old work out equipment from the old facility is no longer necessary or useful to the Village; and

WHEREAS, the Corporate Authorities of the Village have therefore determined to donate the obsolete and damaged equipment that is no longer necessary or useful to the Village; and

WHEREAS, the donation will do the Village a service because the room in which it is currently stored will be cleared of old equipment at no cost to the Village, while a scavenger would charge the Village to remove the equipment.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, in the exercise of the Village’s home rule powers, as follows:

SECTION 1

The above preambles are hereby incorporated into this Section as fully as if restated in their entirety herein.

SECTION 2

The donation of the equipment listed on Exhibit A attached hereto, which equipment is no longer necessary or useful to the Village, some of which is damaged and obsolete, is hereby approved. The Village hereby declares the equipment to be of no value.

SECTION 3

This Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
