## Ordinance No: 4470

ORDINANCE FIXING THE DATE AND TIME FOR INAUGURATION OF THE NEWLY ELECTED OFFICERS OF THE VILLAGE

WHEREAS, the Village President, three (3) Village Trustees and the Village Clerk of the Village of Orland Park, as well as two (2) Library Trustees of the Orland Park Public Library will be elected at the consolidated election of April 7, 2009; and

WHEREAS, this Board of Trustees may, by Statute, fix the time and date for inauguration for the newly elected officers of the Village, such time and date to be no later than the first regular or special meeting of the Board of Trustees in the month of June following the election; and

WHEREAS, the first regular meeting of this Board of Trustees in the month of May following the election is May 4, 2009, and no special meeting of this Board of Trustees is contemplated prior thereto;

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

### SECTION 1

The first regular May, 2009, meeting of the Board of Trustees of the Village of Orland Park, to-wit: May 4, 2009, at 7:00 o'clock PM is hereby fixed as the time and date for inauguration of the Village President, three (3) Village Trustees, Village Clerk and two (2) Orland Park Library Trustees elected at the consolidated election of April 7, 2009.

### SECTION 2

This Ordinance shall be in full force and effect upon its passage and approval as provided by law.
