## Ordinance No: 4256

AN ORDINANCE AMENDING THE ORLAND PARK VILLAGE CODE, TITLE 9, CHAPTER 9, SECTION 3. STOP INTERSECTIONS (115th AVENUE AND 183rd PLACE).

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Illinois.

### SECTION 1

**TRAFFIC TO STOP.** All vehicles moving in a westerly or easterly direction over, upon or along 183rd Place shall come to a complete stop before entering the intersection of 115th Avenue, and all vehicles moving in a southerly or northerly direction over, upon or along 183rd Place shall come to a complete stop before entering the intersection of 115th Avenue, except when directed to proceed by a police officer or as otherwise provided by law.

### SECTION 2

**SIGNS TO BE ERECTED.** Appropriate signs shall be erected to inform the public of these stops.

### SECTION 3

**PENALTIES.** Any person who violates any provision of this Ordinance shall, upon conviction thereof, be fined not less than Twenty-Five (\$25.00) Dollars nor more than Five Hundred (\$500.00) Dollars for each offense of which such person shall be convicted.

### SECTION 4

**REPEAL.** That all ordinances or parts of ordinances in conflict with the provisions hereof are hereby repealed.
