A RESOLUTION IN SUPPORT OF THE CHICAGO METROPOLITAN AGENCY FOR PLANNING'S USE OF AMERICAN RECOVERY AND REINVESTMENT ACT FUNDS FOR THE HICKORY CREEK WATERSHED PLANNING

WHEREAS, Chicago Metropolitan Agency for Planning (CMAP) has been awarded funding from the Illinois Environmental Protection Agency (IEPA) through Section 604(b) of the Clean Water Act as authorized under the American Recovery and Reinvestment Act of 2009; and

WHEREAS, CMAP and IEPA are entering into a Financial Assistance Agreement and intend to use a portion of the award to fund the development of a watershed plan for Hickory Creek; and

WHEREAS, the Financial Assistance Agreement calls for six deliverables: a watershed resources inventory, a watershed plan, an educational brochure, a watershed restoration workshop, an executive summary and a website; and

WHEREAS, the grant award for Hickory Creek watershed planning is \$209,520.00, with a total match of \$58,200.00 from local participating bodies which may be met with in-kind services; and

WHEREAS, the Hickory Creek Watershed Planning Group Planning Group (HCWPG), which was organized in 2008 by various municipalities, county agencies, environmental advocacy groups and other interested parties, desires to participate with CMAP in watershed planning; and

WHEREAS, the Village of Orland Park supports CMAP's participation in and funding assistance for the development of the watershed plan.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ORLAND PARK, WILL & COOK COUNTIES, ILLINOIS AS FOLLOWS:

That the Village of Orland Park is committed to Hickory Creek Watershed planning and will support CMAP's planning initiative and funding with in-kind village services to help meet the local requirements of the Financial Assistance Agreement.
