## Ordinance No: 4318

AN ORDINANCE AMENDING THE ORLAND PARK VILLAGE CODE, TITLE 9, CHAPTER 9, SECTION 3. STOP INTERSECTION (LONG RUN DRIVE AND CORNHILL DRIVE)

NOW, THEREFORE, BE IT ORDAINED by the President of the Board of Trustees of the Village of Orland Park, Illinois.

### SECTION 1

TRAFFIC TO STOP. All vehicular traffic moving in an easterly direction over, upon, or along Long Run Drive shall come to a full and complete stop before entering the intersection of Long Run Drive and Cornhill Drive. All vehicular traffic moving in a westerly direction over, upon or along Long Run Drive shall come to a full and complete stop before entering the intersection of Long Run Drive and Cornhill Drive. All vehicular traffic moving in a northerly direction over, upon or along Cornhill Drive shall come to a full and complete stop before entering the intersection of Long Run Drive and Cornhill Drive, being intersecting streets within the Village of Orland Park, Cook and Will Counties, Illinois, except when directed to proceed by a Police Officer or except as otherwise provided by law.

### SECTION 2

SIGNS TO BE ERECTED. Appropriate signs shall be placed at the intersections in Section 1 of this Ordinance to apprise the public that all vehicular traffic must come to a full and complete stop as set forth in Section 1 hereof.

### SECTION 3

PENALTIES. Any person who violates any provision of this Ordinance shall, upon conviction thereof, be fined not less than Seventy-Five (\$75.00) Dollars nor more than Seven Hundred and Fifty (\$750.00) Dollars for each offense of which such person shall be convicted.

### SECTION 4

REPEAL. That all ordinances or parts of ordinances in conflict with the provisions hereof are hereby repealed.

### SECTION 5

EFFECTIVE DATE. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner prescribed by law.
