AN ORDINANCE AMENDING ORDINANCE NOS. 3967 AND 4589 (COMPENSATION OF CERTAIN ELECTED OFFICIALS)

WHEREAS, Ordinance No. 3967, adopted November 15, 2004, and Ordinance No. 4589, adopted September 21, 2010, provided for the Village President, Clerk and Trustees to be paid their compensation in monthly installments; and

WHEREAS, it is necessary and convenient for the compensation of these elected Village officials to be paid on a bi-weekly schedule in accordance with the Village's regular bi-weekly payroll established for Village employees.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ORLAND PARK, COOK AND WILL COUNTIES, ILLINOIS, as follows:

Ordinance Nos. 3967 and 4589 are hereby amended to provide that the established compensation for the Village President, Clerk and Trustees shall be paid bi-weekly and included with the Village's bi-weekly payroll.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

BE IT FURTHER ORDAINED that the Village Clerk is hereby ordered and directed to publish this Ordinance in pamphlet form, and this Ordinance shall be in full force and effect after its passage, approval and publication as required by law.
