WHEREAS, 16 states across the nation have recognized the health dangers of exposure to second-hand smoke and have banned smoking in public places within their borders; and,

WHEREAS, State Senator John Cullerton has proposed to the Illinois legislature that it adopt Senate Bill 500, the Smoke Free Illinois Act, which would ban smoking in all public places in Illinois and within 15 feet of an entrance to a public place, to be effective on January 1, 2008; and

WHEREAS, this proposed legislation would promote public health as well as ensure economic equity across the State of Illinois among businesses subject to the law; and

WHEREAS, the Village of Orland Park strongly supports public health legislation that affects both the residential and business communities in a fair and balanced manner;

NOW, THEREFORE, BE IT RESOLVED that the Village Board of Orland Park fully supports Senate Bill 500, the Smoke Free Illinois Act, and encourages its citizens, business community and fellow municipalities to voice their support of the proposal to our State legislators for the improvement of public health and the continued viability of our local businesses through passage of the said legislation
