WHEREAS, the Village of Orland Park is the sole owner of all of the capital stock of M&M Investments, Inc., an Illinois corporation, which corporation owns the real estate located at the southeast corner of 153rd Street and 108th Avenue and which real estate is legally described in Exhibit A to the Conservation Grant and Easement attached hereto and made a part hereof; and

WHEREAS, it is the intention that the said real estate be preserved and protected in its natural state as an open land parcel in accordance with the terms and conditions of the Conservation Grant and Easement attached hereto;

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

### SECTION 1:

That the attached Conservation Grant and Easement in favor of the Orland Park Open Lands Corporation in substantially the form attached hereto and made a part hereof be executed by the President and Secretary of M&M Investments, Inc., and thereafter recorded with the Office of the Cook County Recorder of Deeds.

### SECTION 2:

This Resolution shall be in full force and effect upon its passage as provided by law.
