AN ORDINANCE AMENDING THE ORLAND PARK VILLAGE CODE (BID PROCESS)

WHEREAS, the Corporate Authorities of the Village of Orland Park, an Illinois home rule municipality, deem it in the best interests of the Village and its residents to amend the Orland Park Village Code with regard to advertisement and bid procedures for contracts for public works.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

SECTION 1

That Section 1-10-3-2 of the Orland Park Village Code is hereby amended by deleting the Section in its entirety and substituting the following:

When advertisement for bids is to be made, the Village Manager shall cause a call for such bids to be published at least once not less than ten (10) days before the date for opening such bids in one or more newspapers with a general circulation in the Village.

The published notice need give only a general description of the work to be done or the materials to be furnished, but detailed drawings, plans, profiles and specifications as prescribed by the President and Board of Trustees for such improvement shall be made and placed on file in the office of the Village Manager prior to the publication of such advertisement and shall at all times be open to public inspection.

Such notice shall also contain such conditions and restrictions as to bids, prerequisites as to bidders, obtaining of plans and specifications, security, deposits, withdrawal or rejection of bids, proposals, contracts and performance bonds as the President and Board of Trustees may direct.

In all advertisements the right to reject any and all bids shall be expressly reserved.

The public notice shall be in substantially the following form:
