AN ORDINANCE AMENDING THE LAND DEVELOPMENT CODE AND ZONING MAP OF THE VILLAGE OF ORLAND PARK, AS AMENDED (2006, VILLAGE CENTER DISTRICT AMENDMENTS)

WHEREAS, the Corporate Authorities of the Village of Orland Park, an Illinois home rule municipality, have on February 8, 1991, adopted a Land Development Code ("the Code") and zoning map; and

WHEREAS, amendments to the Code and map are adopted from time to time to insure that they are up to date and responsive to community needs; and

WHEREAS, recent amendments have been proposed regarding the map and provisions of the Code relating to the Village Center District; and

WHEREAS, the Plan Commission of the Village held a public hearing on March 14, 2006, on whether the proposed amendments should be made, at which time all persons present were afforded an opportunity to be heard; and

WHEREAS, a public notice in the form required by law was given of said public hearing by publication not more than thirty (30) days nor less than fifteen (15) days prior to said hearing in the Orland Park Star and the Daily Southtown, newspapers of general circulation in this Village, there being no newspaper published in this Village; and

WHEREAS, the Plan Commission of this Village has filed its report of findings and recommendations that the attached proposed amendments to Section 6 of the Land Development Code and to the zoning map of the Village be made, and this Board of Trustees has duly considered said report and findings and recommendations.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

SECTION 1

This Board finds and determines that the adoption of the attached amendments to the Land Development Code and the zoning map of the Village of Orland Park are in the best interests of the Village and its residents, are in the public interest, constitute an improvement to the Land Development Code of the Village of Orland Park, and are in keeping with the spirit and in furtherance of the purpose of the Land Development Code of the Village of Orland Park, as set forth in Section 1-102 thereof.

SECTION 2

The Land Development Code of the Village of Orland Park, as amended, is hereby further amended to delete in their entirety existing Section 6-212 (Village Center District) and existing Section 6-314 (Design Standards, Village Center District) and replace those Sections with new Section 6-212, attached hereto as Exhibit A.

SECTION 3

The zoning map of the Village of Orland Park is hereby amended to designate the new boundaries of the Village Center District as shown in Exhibit B, rezoning those parcels which previously fell outside of the boundaries of the Village Center District from their former classification into the Village Center District classification.

SECTION 4

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed insofar as they conflict herewith.

SECTION 5

This Ordinance shall become and be effective immediately upon its passage, approval and publication in the manner provided by law. It is ordered that publication of this Ordinance be made by duplicating thereof in pamphlet form said pamphlets to be deposited in the office of the Village Clerk of the Village of Orland Park, for general distribution.
