AN ORDINANCE AMENDING TITLE 4 OF THE ORLAND PARK VILLAGE CODE (LAWN SPRINKLING, WELLS AND PONDS)

BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

## SECTION 1

Title 4, Chapter 8, Section 3 of the Orland Park Village Code is hereby amended to add the following sentence at the end of sub-section 9: "An approved application shall result in a permit for such installation. The permit may be conditioned as the Director of Public Works finds necessary or appropriate to meet the requirements of this sub-section."

## SECTION 2

Title 4, Chapter 8, Section 3 is hereby amended to add at the end of the Section, a new sub-section, sub-section 11, to read in its entirety as follows:

"11. Outdoor watering systems permitted pursuant to sub-section 9, above, shall be exempt from the restrictions and requirements of sub-sections 1, 2, 5 and 6 of this Section 4-8-3."

## SECTION 3

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of their conflict herewith.

## SECTION 4

This Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner prescribed by law.
