## Ordinance No: 4159

AN ORDINANCE AMENDING TITLE 5, CHAPTER 2 OF THE ORLAND PARK VILLAGE CODE  
(AUXILIARY WATER SYSTEM INSPECTION FEES)

WHEREAS, the Village of Orland Park, Cook and Will Counties, Illinois, an Illinois home rule municipality, has adopted various fees for building permits and for installation of systems associated with building and development, including water and certain water use systems: and

WHEREAS, the Village has determined that it is appropriate to revise its fees for water taps taken from an existing water line to supply auxiliary water systems such as lawn sprinkler systems or ornamental fountains.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

### SECTION 1

The Orland Park Village Code, Title 5, Building, Chapter 2, Fees, Subsection 5-2-7-10 Miscellaneous Fees, is hereby amended in sub-part f, Lawn Sprinkler System Fee, to delete the entire sub-part, including its title, and substitute the following:

"f. Water Taps From an Existing Water Line to Supply Auxiliary System Uses (Includes lawn sprinkler systems, ornamental fountains. Backflow prevention required.)

A fee of \$60 per inspected water supply line

Note: Water lines to be taken from retention or detention ponds for the supply of lawn sprinkler systems (or similar uses) must obtain a permit from the Public Works Department before installation."

### SECTION 2

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed insofar as they conflict herewith.
