## Ordinance No: 4160

AN ORDINANCE AMENDING TITLE 6, CHAPTER 2, NUISANCES, OF THE ORLAND PARK VILLAGE CODE (HIGH GRASS)

WHEREAS, the Corporate Authorities of the Village of Orland Park are empowered to define, prevent and abate nuisances; and

WHEREAS, the Corporate Authorities of the Village of Orland Park have previously determined that noxious weeds growing to a height of over 8 inches are a public nuisance; and

WHEREAS, the Corporate Authorities have determined that grass growing to a height of over 8 inches is also a public nuisance; and

WHEREAS, the Corporate Authorities wish to add regulations pertaining to high grass to the provisions regulating weeds.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

### SECTION 1

The above preambles are hereby incorporated into this Ordinance as fully as if restated herein in their entirety.

### SECTION 2

Title 6, Chapter 2, Nuisances, of the Orland Park Village Code is hereby amended to change subsection 6-2-2-7 by adding the bolded and underlined sections of as indicated on Exhibit A attached hereto and made a part hereof.

### SECTION 3

This Ordinance shall be in full force and effect upon its adoption, approval and publication as required by
