## Ordinance No: 4169

AN ORDINANCE AMENDING TITLE 6, CHAPTER 4, NOISE CONTROL, OF THE ORLAND PARK VILLAGE CODE (EQUIPMENT AND MACHINERY)

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

### SECTION 1

Title 6, Chapter 4, Noise Control, of the Orland Park Village Code is hereby amended to add the underlined words below to item 1 in sub-section 6-4-2-4, Equipment and Machinery so that it reads as follows:

"1. It shall be unlawful for any person to use any pile driver, shovel, hammer, derrick, hoist, tractor, roller, power or chain saw, power lawnmower or other mechanical apparatus operated by fuel or electric power in building or construction operations or in outdoor private business or residential use, between the hours of nine thirty o'clock (9:30) P.M. and 7 o'clock (7:00) A.M., except for work on public improvements and work of public service utilities, within six hundred feet (600') of any building used for residential or hospital purposes."

### SECTION 2

This Ordinance shall be in full force and effect upon its adoption, approval and publication as required by law.

### SECTION 3

The Village Clerk is hereby directed to publish this Ordinance in pamphlet form, said pamphlets to be deposited in the office of the Village Clerk for general distribution.
