## Ordinance No: 4190

AN ORDINANCE AMENDING THE ORLAND PARK VILLAGE CODE (HANDICAPPED PARKING FINES)

WHEREAS, the Corporate Authorities of the Village of Orland Park, an Illinois home rule municipality, deem it in the best interests of the Village and its residents to amend the Orland Park Village Code with regard to fines for violation of vehicular standing, parking or compliance regulations.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, an Illinois home rule municipality, as follows:

### SECTION 1

That the Fine Payment Schedule in Sub-Section 9-15-9-1 of the Orland Park Village Code is hereby amended by changing the fine amounts in the "Handicapped Fine Amount" column as follows:

1. For Step 1, \$200.00.
2. For Step 2, delete \$300.00 and substitute \$275.00.
3. For Step 3, delete \$500.00 and substitute \$350.00.

### SECTION 2

All other parts of Sub-Section 9-15-9-1 shall remain unchanged and effective, and all parts of Chapter 9 not specifically changed by this Ordinance shall remain unchanged and effective. All ordinances in conflict with this Ordinance are hereby repealed to the extent of the conflict.

### SECTION 3

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
